BUSINESS

The meeting opened with a few welcoming words from our President, Christel Morrison.

The first item of business discussed was the Revenue and Expense Report. Copies were available for all who attended. The loss reported was due to repairs made and supplies used for the Pool. On a positive note, the pool has a new chlorinator that will aid in reducing the price of chemicals for the 2008 swim season.

Second item was the 2008 Projected Budget. Again, copies were available for those in attendance. Though there was a loss, we still reported a carry over of funds from 2007 to 2008.

Community Involvement:

Illumination of Lights (whether coach lights of garage or post list in yard) at night still being requested and is stated as mandatory in our POA bylaws.

Reminders will be sent to our residents for:

1. All trash receptacles are to be placed out of sight-preferably kept in owners' garages.

- 2. Mail boxes needing replaced should be handled through Mail box Solutions info is on our page. The <u>Green</u> mailboxes currently seen are temporary from the Town of Fishers as temporary replacements for those destroyed by the snow plows.
- 3. Pets: Pet owners are to be considerate of all our residents by NOT allowing dogs bark for long periods of time in early morning or late in the nights. All dogs should be restrained by, fence, invisible fence or leash according to Indiana State Leash Laws. Cat owners should monitor their cats as well since complaints have been received about destruction to landscaping. Cleaning up after pets is mandatory in the parks and along walking routes.
- **4.** Retention Ponds please keep area clean from all trash. No swimming, skating or horseplay is allowed in and or around the pond area.
