Lawn care – community grounds

- o Provided by Mustard Seed and Sta Green.
 - Mustard Seed mowing and grounds upkeep
 - Sta Green lawn and tree chemical applications
 - Lost another tree early in 2011 4 total
 - a. Arborist inspected down trees and determined they were diseased and most likely caused by lawn clipping around base suffocating roots and allowing mold and disease to set in. Lawn clippings are no longer allowed to be put around trees.
 - b. Most PO's don't want trees replaced since it gives the park a more open feeling on the North side.
 - Trees along 131st street were treated for scale with great success. 8-10 trees could possibly been killed by scale, but treatment saved them.
 - New black mulch was laid down and mixed in with existing

- Sprinkler Box was replaced vandalism
- Front entrance light sensor was replace

Pool care and issues

- Provided by Splash
 - Cut-off Valves were installed. State law mandated
 - Leaking copper pipe over men's 1st shower stall
 - Leak was fixed by professional plumber
 - Drywall was severely damaged and was replaced and repainted by Andy Porter
 - Pool umbrellas were fixed by the Rook family at significant savings over purchase replacements.
 - \$800 to replace, \$280 to repair 6
 - Lifeguards did well with no major issues and no Board of Health violations

Property Owners upkeep

- o Property values continue to drop and owners struggle with upkeep and repairs
 - Mailboxes badly damaged
 - Missing siding
 - Cars parked in street
 - Homes in disrepair
- o Letters sent by Board receive no positive action from homeowners
 - No way to currently enforce restrictions / bi-laws
 - Board to look into if fees can be assessed for non-compliance
