HOME VIOLATIONS

Ensuring compliance with the rules in our POA community is crucial to maintaining the beauty of our homes. This process will continue through the upcoming spring and summer seasons. If you receive a letter, please be aware of the following:

You will have a 30-day window to inform the Board about how you plan to rectify any issue(s) cited in the letter. We understand that installing mailboxes and posts can take several weeks, so we simply ask that you inform us if you have already ordered the necessary items or if you are in the process of hiring a professional to address the issue. After three letters, if we still have not heard from the owner, we will be forced to suspend pool privileges, and we may need to turn the matter over to an attorney for further action.

The Board is committed to upholding the rules for everyone in our community. We believe that each resident has a role to play in keeping Sweet Briar beautiful.

- We are so excited to have launched the new Appfolio management software program. Now all of your architectural reviews, home violations, and email correspondences will be housed under your homeowner portal! This program also helps streamline our accounting needs and houses important information for generations to come!

POOL CARDS

If you're new to the neighborhood, the previous owner should have left you a white plastic key card for pool access. If you have one, you're all set and don't need to take any further action. However, if you don't have one, please stop by on opening day, and we'll provide you with a new card.

In case you lost your pool card, please note that there is a \$25.00 replacement fee, and you can pick up your card on opening day.

Please remember that access to the pool is contingent upon paying your assessments and addressing any outstanding violations. If you haven't done so, you won't be able to use the pool facilities.
